PURPOSES OF PROCESSING

The purposes for which the data are collected are the following:

Moreover this site gathers information concerning the users' booking requests in order to offer them an appropriate pricing.

PLACE OF DATA PROCESSING

The processing linked to the web services of this website takes place in the above mentioned head office of Via Di Carbonifera 14, Loc. Torremozza, 57025 Vignale Riotorto (LI) and it is carried out only by the technical staff of the Office in charge with the processing. In case of need, the data connected to the newsletter service may be processed by the staff of the company which handles the maintenance of the technological part of the website Waika srl at the head office of the said company.

TYPES OF DATA PROCESSED

The following types of data are processed:

Web browsing data

The computer systems and the software procedures underlying this website, through their ordinary working, gather a few personal data which are implicitly transmitted while using the Internet communication protocols.

It is a sort of information which is not collected to be linked to identified data subjects but which, for its own nature, might enable to identify the users through processing and associations with data held by third parties.

This category of data comprises IP addresses or the names in the domains of the computers used by

the users who log on to the website, the addresses in URI notation (Uniform Resource Identifier) of the resources requested, the time of the request, the method used to make the request to the server, the size of the file received as feedback, the number code indicating the status of the feedback sent by the server (successful, failed, etc.) and other parameters related to the operational system and to the computer environment of the user.

These data are utilized only to the purpose of obtaining anonymous statistical information about the use of the website and in order to monitor its correct functioning; they are deleted immediately after their processing. Activities strictly required for functioning
